## Renewal starts October 1, 2020!

This is in response to Covid-19 and needing to limit capacity, please plan to renew early. **Private Applicator Certification** (PAC) is required for Restricted Material Permit applicants and those using federally restricted products. PAC's with last names beginning with **R-Z** expire on **12/31/2020**. Renewal of PAC's will require 6 hours of Continuing Education. (2 hours of which must be Laws and Regulations)

If you would like to renew your Certificate with Continuing Education hours, bring copies of your class attendance with you when you come in for Permit renewal.

Private Applicator exams will be available on a walk-in basis. Tests will be available from 8:00 A.M – 3:00 P.M., Monday through Friday, at the Tulare County Agricultural Commissioner's Office Auditorium located at 4437 South Laspina St. Tulare, CA 93274 Phone (559) 684-3352

We will be limited on capacity, so if you need to send more than 5 employees please call ahead and schedule.

#### **Weights and Measures Division**

Hi. I am the Deputy Sealer in Weights and Measures, but I have not always been. I have a degree in Botany and a minor in Entomology. However, the love of my life is Meteorology, but I digress. I graduated from a four-year university on the five-year plan and worked as a Pest Control Advisor for a farming corporation on the west side of the San Joaquin Valley. In the late 80's I became a seasonal trapper for the Tulare County Agricultural Commissioner's Office and eventually became a fulltime inspector and started my career. The first division I worked in was Standards where I tested oranges for maturity.

I also worked part-time for the Pesticide Division collecting water runoff samples for the Department of Pesticide Regulation. Shortly thereafter, I started working full-time in the Pesticide Division assisting the District Inspectors, issuing permits, checking Notices of Intent and other duties. During the early 90's I became a District Inspector in the Pesticide Division, my primary duties were conducting structural pesticide applications, and pesticide illness investigations while filling in for District Inspectors when they had office duty or were on vacation. I investigated several high-profile pesticide illnesses during that tenure. In 2002, I became an Inspector IV in the Pesticide Division supervising a staff of District Inspectors and more. As an Inspector IV, I conducted employee evaluations, reviewed and approved investigative reports and inspections, wrote Notices of Proposed Actions and acted as the advocate when hearings were requested, kept records of paperwork and reported such paperwork to the Department of Pesticide Regulation. In late 2011, I applied for and was given the position of Deputy in our Weights and Measures Division. It has been a steep learning curve since most of my experience has been with the agricultural side of our Department. Luckily, I had a great staff to learn from and work with and that continues today. Even though most of my work is in Weights and Measures, I still have some agricultural duties on my side of the office. I am responsible for the Certified Producer and Organic programs as well as enforcing the Walnut Theft Ordinance. In 2020, we have embraced a new program - Industrial Hemp. We started registering and permitting growers and processors alike. As time goes on, the one thing I have learned is to treat the industries we serve with fairness and respect in all of what we do.

#### A look inside Weights and Measures



One of the biggest challenges in Weights and Measures is technology. Some things as simple as scales are becoming more complex with the electronics becoming smaller and more sophisticated. Electricity, hydrogen and compressed natural gas are a few examples of new vehicle fuels. As they become more common throughout the state the devices that deliver that fuel will be more common and just like the gasoline pumps are tested by our office now, the devices delivering these new fuels will be tested as well. COVID-19 has impacted our department in that our ability to inspect devices has slowed down. We are wearing masks and gloves to protect ourselves and the industry when the risk of exposure is high.



Nicole Motley; Deputy of Pest Exclusion & Standardization

#### Pest Exclusion & Standardization Division

My name is Nicole Motley and I was born and raised in Tulare, California. I was involved in agriculture from a young age as my grandfather and uncles owned a dairy. I was heavily involved in both 4-H and FFA with raising swine, sheep, and dairy cattle. I participated on livestock judging teams and public speaking teams throughout my youth and into my college years. I attended College of the Sequoias where I graduated with my associate's degree. I then transferred to Fresno State where I graduated with a Bachelors of Science degree in Agricultural Business. I have been married to my husband Jeff Motley for 12 years. I have three children, Makenna is 10 years old, Madison is 7 years old, and Merritt is 2 years old.

I started my career with the Tulare County Agricultural Commissioner/Sealers Office in January 2012 as an Agricultural & Standards Inspector Trainee. I was promoted to Agricultural & Standards Enforcement Officer in January 2017. I was then promoted to Agricultural & Standards Inspector IV in November of 2017 in the Pesticide Use Enforcement Division. Now I am the Deputy Agricultural Commissioner in charge of the Pest Exclusion & Standardization Division.

The Pest Exclusions & Standardization Division has many different programs within its division. These programs are intended to prevent the introduction and/or spread of plant pests and diseases which may be detrimental to agricultural crops in Tulare County. We have around 35 Agricultural and Standards Inspectors who work in 8 different districts throughout the county. Our inspectors provide essential services by certifying shippers' compliance with other county, state, and foreign countries quarantine requirements, allowing products to be shipped around the world. Our inspectors are federally certified to perform Phytosanitary Inspections and certifications.



Currently our inspectors are finishing up inspections, fumigations, and issuing Phytosanitary Certificates for the stone fruit season. Our inspectors are also currently performing inspections and fumigations on table grapes and performing table grape maturity tests in accordance with California State standards. Our inspectors will soon be transitioning into citrus season where they will start citrus maturity testing and inspections for exports to multiple different countries. On a different note, we didn't see too much effect from COVID- 19. Most facilities stayed up and running and our inspectors followed all COVID-19 precautions while performing their job duties.

### Pest Detection, Pest Management, and Crop Statistics Division

Greetings and Salutations! My name is Jonathan Bixler, I was born in Visalia and raised on a small farm in Tulare, CA. Throughout my childhood I worked on the family dairy/farm raising Jersey cows and producing alfalfa, oat hay, plums, walnuts, corn, and cotton. I graduated from the University of California, Santa Cruz with a degree in Molecular, Cellular, and Developmental Biology in 2005. After college, I worked at the Sunkist Juice Plant in Tipton as a Quality Assurance Lab Technician testing the quality of orange juice and working on research and development.



Jonathan Bixler; Deputy of Pest Detection, Pest Management, and Crop Statistics

I moved to the Bay Area and became a Biologist/Standards Specialist with the San Mateo County Agricultural Commissioner's office in 2007. I worked in the Exclusion, Standards, and Weights and Measures divisions of the department for a total of 9 years. I moved back to my hometown in 2016 and took a position with Tulare County as the Deputy Agricultural Commissioner of the Exclusion and Standards Division. Currently, I am in charge of the Pest Detection, Pest Management, and Crop Statistics Division. My hobbies include ocean kayaking, hiking, electronics projects, woodworking, composing and performing music. As Deputy in charge of Crop Statistics, it is my responsibility to make sure the Crop Report is completed accurately and published on a yearly basis. Not only is it a useful resource for many industries, publishing a Crop Report is a requirement by law in the Food and Agriculture Code § 2279.

"The Commissioner shall compile reports of the condition, acreage, production, and value of the agricultural products in his/her county. The Commissioner may publish such reports and shall transmit a copy of them to the Director."

As noted in the code section above, the Crop Report summarizes the agriculture activities in Tulare County. The sections of the Crop Report include: Permanent Planting Acreage, Field Crops, Fruit & Nut Crops, Vegetable Crops, Nursery Products, Apiary Products, Seed Crops, Industrial Crops, Livestock & Poultry, Livestock & Poultry Products, Summary, Million Dollar Products, Category Comparison, Twenty-Year Value Comparison, Top Export Commodities, Export Countries, Sustainable Agriculture, Pest Detection, and Registered Organic & Certified Producer. We send out letters to industry requesting information regarding value, production and acreage. That data is compiled and compared to information from other counties, the National Agricultural Statistics Service (NASS), and the California Department of Food & Agriculture (CDFA). By doing this we are able to establish accurate figures that best represent acreage, value, and production for agriculture in Tulare County. Accurate numbers are very important because the Crop Report is used by industry to make important decisions that can have a large impact on Tulare County.


