# EXHIBIT 1386-PH PACKER / PROCESSOR OF MANDARINS WITH ATTACHED STEMS AND/OR LEAVES

#### PROVISIONS FOR THE INTRASTATE OR INTERSTATE MOVEMENT OF MANDARINS WITH ATTACHED STEMS AND/OR LEAVES FROM OR WITHIN AN ASIAN CITRUS PSYLLID BULK CITRUS REGIONAL QUARANTINE ZONE

# Establishment agrees to the following:

# 1. Eligible Mandarins with Attached Stems and/or Leaves

- a. Mandarins with attached stems and/or leaves grown/originating from an area quarantined for Huanglongbing (HLB) or regulated for Sweet Orange Scab (SOS) are not eligible for this permit.
- b. Mandarins with attached stems and/or leaves grown/originating within an ACP bulk citrus regional quarantine zone shall not be packed/processed in an area that is quarantined for HLB or regulated for SOS.

# 2. Establishments Under Compliance

The Establishment shall ensure the fruit is shipped from a Grower/Grove Manager or Packer/Processor under compliance with the ACP Program and transported/hauled by Transporters/Haulers under compliance with the Program.

# 3. Intrastate and Interstate Shipments Under Master Permit QC 1386

Under Master Permit QC 1386, eligible mandarins with attached stems and/or leaves may be shipped intrastate or interstate if compliant with the following requirements:

- a. Mandarins with attached stems and/or leaves grown within an ACP bulk citrus regional quarantine zone and not in an area quarantined for HLB or SOS may be shipped <u>intrastate</u> to packing/processing facilities in any ACP bulk citrus regional quarantine zone. Shipment must be contained within a fully enclosed vehicle or be completely safeguarded in transit.
- b. Mandarins with attached stems and/or leaves must not be commingled at any time with any other fruit.
- c. All green waste found in the transportation vehicle and falling from the mandarins during packing/processing shall be continuously collected, double bagged, and disposed of in a landfill in a Program approved manner.
- d. The Establishment shall notify the local County Agricultural Commissioner as soon as possible and no later than 24 hours after spillage of any shipment.
- e. When all the compliance agreement requirements have been met and eligible mandarins are packed under industry standard packing house procedures (#4), the packed mandarins with attached stems and/or leaves may be transported <u>intrastate</u> or <u>interstate</u>.

# 4. Industry Standard Packing House Procedures

All mandarins with attached stems and/or leaves must undergo standard industry packing house procedures which include, but are not limited to, washing with brushes, disinfestation, waxing, drying, culling, grading, and final packing.

# 5. Shipments Received from a Grower, Transporter, or Other Establishment NOT Under Compliance If a shipment arrives

• From a Grower/Grove Manager, Transporter/Hauler, or Packer/Processor not operating under compliance, or





- If the shipment arrives not fully enclosed or safeguarded in accordance with the terms listed in Compliance Agreement Exhibit "1386-T", or
- Without an "ACP-Free Declaration" form (if required)

All of the following must be implemented:

- a. Do NOT pack/process the shipment.
- b. Immediately contact the local County Agricultural Commissioner.
- c. Segregate the shipment from all other ACP host material and apply proper safeguards to avoid potential spread of ACP. For approved safeguarding measures, contact the local County Agricultural Commissioner or ACP Program.
- d. Provide all shipping documents/certificates accompanied with the shipment to agricultural officials upon request.

#### 6. Cleaning Equipment

All equipment (including containers, barrels, bins, etc.) used for harvesting and transporting/hauling mandarin fruit must be free of leaf and stem debris after use and cleaned as soon as possible.

#### 7. Green Waste Disposal

All green waste, including leaf and stem debris, must be continuously collected and disposed of in accordance with the Program, local County Agricultural Commissioner, under QC Master Permit 1289 or other Program approved manner.

#### 8. Trapping and Inspection

The Establishment shall allow agricultural officials to inspect the premises to ensure compliance with this exhibit, and to place and service traps for the detection of ACP.

#### 9. Records

Maintain records of all ACP host shipments, including green waste, for a minimum of two years and provide the following shipment information to the local County Agricultural Commissioner on a weekly basis.

- a. Number of boxes shipped and pounds per box
- b. Destination county or state

#### 10. Training

Ensure all employees receive training to be compliant with all specifications of the compliance agreement and this exhibit.

#### 11. Information Posting

The Establishment shall regularly verify current regional quarantine zones. The most up to date information may be viewed at: <u>https://www.cdfa.ca.gov/plant/acp/regulation.html</u>. The Establishment shall also display informative posters and associated ACP information in a conspicuous location if supplied by the Program.

#### 12. Violation

Violation of any terms of the compliance agreement or this exhibit shall result in the suspension of the compliance agreement until an investigation is completed and for a minimum period of two weeks.
